Consignment Contract

Terms of Sale

This contract is devised to work for sales of a large amount of items. The items will be sold depending on my research on Ebay, yard sale, and/or Facebook Marketplace.

Ebay/Facebook Marketplace

In order to sell your item for you, I need possession of your item so that I may photograph it, write an accurate a description of the item as possible, and post it for sale. If, and when, the item sells and I have received payment from the customer for it - I will be responsible for packing and shipping the item to the winning bidder. If an item does not sell, and you do not wish to re-list it for sale, I will return the merchandise to you. If the item does not sell, you are still responsible for paying any and all eBay fees associated with the auction and the postage to return to you. You will receive a list of items sold with final totals and any extraneous fees that may be applicable. The amount of time from beginning of the sale, to the finalization can vary greatly - the sale is not considered "finalized" until the customer has paid for, and received the merchandise. Most customers pay quickly, some take longer.

Please note that once an item is listed on eBay for sale, it MUST be sold to the winning bidder - unless you wish to place a reserve price on the item. A reserve price means you do not have to sell the item unless your specified price is met. eBay does charge a fee for listing an item with a reserve price - BUT if the item sells for your reserve fee (or higher), eBay will refund the initial charge for the reserve price. If you wish to place a reserve price on your item, and agree to pay the eBay fee for such, please list your reserve price here _____ and initial here _____. (Leave blank if you have filled out **Contract Addendum A.**)

You may select an "opening bid" price for your item or you may elect for me to select an opening bid price for you. When I select an opening bid, my price is based upon looking at auctions of similar items, and the current re-sale value of the item. Please note that most opening bids are set low enough to entice a customer to bid on your item, but high enough to cover the associated fees for selling the item for you plus a small profit. eBay charges an insertion fee relative to the opening bid price, the lower the opening price, the lower the fee for listing the item. If you wish to set an opening price (this would be the lowest amount of money you would be willing to accept for the item), please list it here _____ and initial here _____. (Leave blank if you have filled out **Contract Addendum A.**) If you do not specify an opening bid, I will select one for you. Please note, that I do offer coupons during the year, please determine your price based on this. The coupon is usually 20% or lower. Make me aware of the items you are firm on price, so I can adjust the price accordingly.

For items that were returned to me from a buyer that I already paid you for, they will become the property of Hodgepodge Stuff.

I will charge you a commission based on the final selling price. I charge 35% per item that sells under \$200 and 20% per item for anything above \$200, this includes any fees, research, time devoted to listing/selling/shipping. Any additional fees that apply as stated above will be charged separately. Please initial here to note that we have agreed on this percentage _____. I usually pay the consignor monthly unless there are a lot of sales, then I pay sooner.

If there are any items that you want returned, please let me know. For any items that I can't sell, I will offer for free on Facebook Marketplace or donate to local charity/church. My ultimate goal is to keep things out of the landfill as much as possible. Please initial if you agree _____.
